ACCOMPANIMENT WITHIN 10 DAYS OF WINNING THE ELIMINATION ROUNDS.* ELIMINATION ROUNDS PARTICIPANTS WILL RECEIVE 5 COMPLIMENTARY TICKETS TO THE U.S.-PHILIPPINES EXPO; ELIMINATION ROUND WINNERS WILL ALSO RECEIVE A FINALIST CERTIFICATE. *A TOTAL OF 12 FINALISTS PER COMPETITION WILL COMPETE DURING THE U.S.-PHILIPPINE EXPO AT THE FAIRPLEX IN POMONA, CA. 2	<b>ORGANIZER:</b>

3	<b>CONTESTANT AND/OR FINALIST:</b>
A	As stated on first page of this Singing Star Competition Agreement.
4	<b>EVENT/ENGAGEMENT:</b>
A	The Organizer will produce and exhibit the cultural, trade and consumer exposition, U.S.-PHILIPPINES EXPO, on _____ at the Fairplex, Los Angeles County Fairground, Bldg. 4 1101 West Mc Kinley Ave. Pomona, CA 91768 and the Contestant and/or Finalist hereby engages to participate in the U.S.-PHILIPPINES EXPO 2007 Singing Star Competitions.
B	Schedule/Activity: The Contestant and/or Finalist will participate during the Singing Star Competitions, at the engagement mentioned above, within the Singing Star Competitions component segment of the event.
5	<b>THE ORGANIZER SHALL PROVIDE:</b>
A	Activity space, to accommodate the Contestant and/or Finalist; accessible with reasonable time for effective and efficient preparation to participate during the Singing Star Competitions. Activity space and facilities shall be in ready condition (clean, clear of items, properly heated, and lighted; equipped with mirrors, tables, chairs, restroom, closet, etc., as well as refreshments).
B	Full compliance with activity schedule.
C	Contestant and/or Finalist a schedule outlining details of Contestant and/or Finalist's activity times for the event, at least 14 days prior to the event.
D	Necessary staff, to guide the Contestant and/or Finalist during the Singing Star Competitions, such as a show director, backstage ushers, and custodians, etc. for the activity.
E	Five (5) complimentary tickets to each participant for the event. Finalists will receive an additional certificate during Elimination Rounds. G	Monetary award to Top Two Finalists, for Singing Star and Junior Singing Star Competitions, payable within 30 days after the event.
6	<b>THE CONTESTANT AND/OR FINALIST SHALL PROVIDE:</b>
A	The above mentioned (4B) activity.
B	Full compliance with the activity schedule.
C	Lodging accommodations and all incidental fees incurred by the Contestant and/or Finalist to be the sole responsibility of the Contestant and/or Finalist.
D	<i>Optional:</i> Upon request of U.S.-PHILIPPINES EXPO tickets to support the event through volunteer ticket sales; the contestant/finalist shall provide the Organizer with the ticket sale proceeds minus commission.
E	Its own permits and/or licenses necessary to engage in the event activity. Any activity will remain sensitive to the audience by not containing any possible defamatory and/or obscene matter.
F	Necessary costumes/props/scenery for any activity.
G	Valid I.D. and biographical data with photograph to accompany application; compatible musical arrangement/accompaniment such as a C.D. within 10 days of winning the Elimination Rounds.
7	<b>INSURANCE:</b>
A	The Contestant and/or Finalist must comply with fire prevention, health, customs, and public safety laws, ordinances, and regulations during the event. The Organizer carries general liability insurance as required by Fairplex.
8	<b>SECURITY:</b>
A	The Organizer shall provide security for the Contestant and/or Finalist. The Organizer takes no responsibility for any stolen, lost, and/or damaged items. No backstage passes permitted.
9	<b>EVENT PROGRAM MATERIALS:</b>
A	The Organizer shall provide an Event Schedule/Program.
10	<b>ORGANIZER &amp; CONTESTANT AND/OR FINALIST INITIATED PROMOTIONS:</b>
A	Both parties allow for the use of their respective names/logos solely in conjunction with the event, while maintaining ownership of their respective names/logos and creative elements and materials for promotions. Both parties may attend pre and post promotional events. Both parties also must review promotional materials for approval with consideration for promotional schedules.
